This was the fourth year that Zoar Lutheran used the "Blessed to be a Blessing" stewardship program. Every fall the "Blessed to be a Blessing" forms are mailed to each congregation member, and also to those who participate regularly with usThis is Zoar's program to individually examine the time and talents of each of us. After Pastor Daren's arrival this past summer, he had the opportunity to reviewed these forms and finds them to be useful tools. Not only do the forms help create a church budget for 2016, but they provide Pastor Daren and the Leadership Team an insight to know where each of you wish to serve. It provides a glimpse of our interests. Interests that you wish to share as members of Zoar Church.

The estimate of Giving forms are reflected in the church budget for the coming year. The 'Estimate of Serving' are used to fill the many activities of the church such as worship, music, altar guild, mission activities and maintenance. As the "Estimate of Serving" form is implemented, it helps us create a list of volunteers to call when extra hands are needed at the church. Fortunately the list comprises of those individuals, volunteering in their field of their interest. Work gets done without making unnecessary telephone calls. It creates a "win, win" situation for all.

The "Estimate of Giving" form enables the opportunity for each member to state their personal tithing amounts. This is not a bound covenant. As stated on the form your tithing amount can be changed at any time during the year. Many extenuating factors such as unemployment or health issues can impact our ability to meet our tithing during the year. If these changes should happen, it may result in re-evaluating your circumstances and your ability to tithe. The same is true when completing the "Estimate of Serving" form." Your health conditions and time commitments impact volunteer hours. Likes and dislikes change as we grow older and become more involved in community activities. To fill out the "Estimate of Serving" each year gives everyone the opportunity to do different things that require volunteers within the church body.

This year the returned and completed estimate forms were smaller than last, BUT we are grateful to have for the returned forms for the planning of the future and the mission work of Zoar Church.

A stewardship program is difficult to facilitate. It contains difficult and sometimes painful decisions for each of us to make. For the present, we feel the "Blessed to be a Blessing" program is a way of reaching all of our membership whether or not one chooses to participate. Zoar Women Report

BIRTHDAY CLUB

Besides enjoying a birthday celebration and friendship at a luncheon, mission work is a focus of the Birthday Club. The club meets monthly to celebrate birthdays of each member. Sometimes there are just a few birthdays to be celebrated, other months there are many birthdays. The luncheon destinations are enjoyable and it gives the participants an opportunity for sharing the events currently taking place in their lives. Because no presents or cards are exchanged, a collection is taken and the club decides on a mission to support. During the summer and fall months. Samaritan Purse Christmas Shoe Boxes is the main mission of focus for the Birthday Club. In October the Birthday Club gather together to make up the Samaritan Purse Christmas Shoe Boxes. Packing these boxes is done at Zoar Church and it is a fun event. Most often a luncheon at Coho Café follows for fellowship. All in all, sixty eight show boxes were packed with toys, school supplies, hygiene items, and accessories like tee shirts, socks, and hats. This project could not have been completed without the generosity of the women participating in the Birthday Club, and those community members who dropped off their donation gifts. The shoebox, most often, is the first gift many children ever receive. The treasures inside communicate that someone cares for them and gives them an opportunity to experience the love of God. After receiving shoebox gifts, boys and girls are invited to enroll in "The Greatest Journey", a 12-lesson discipleship program designed by Samaritan Purse. They learn from trained local volunteers what it means to faithfully follow Christ and share their faith with others.

Women of Zoar Church

This past year, we have not met as a group for sewing projects, but the women continue to do projects for sharing with others. Priscilla knit hats for preemies at St Luke's Hospital, and for Sea Farers in Duluth. Shirley S continues to organize our Prayer Shawl/Prayer Squares ministry. Pam I assists us the pillowcase ministry. In addition to pillow cases for the hospital pediatric unit, we have made some to keep at church for giving to other community members. The women support the pastor at Good News Club, an after school program held in the Birch Grove Library Room. We appreciate those who provide snacks, craft ideas, music, and attend this once a week program providing Bible stories, songs and faith stories with our young people.

Trustee's Report

These projects were undertaken and completed during the 2015 calendar year:

- New carpeting in the upstairs of the parsonage
- Cleaning and painting in the parsonage basement
- Replacing several damaged storms and screens at the parsonage
- · New carpeting in the basement Pastor's Study
- · Replacing several lighting fixtures and bulbs on the church building exterior

The Trustees recommend completing the following projects during the 2016 calendar year using available budgeted funds, grants, and specially marked donations:

- Upgrade our water system:
 - Test and possibly cap the well behind the garage
 - Replace microfiltration system with a state approved alternative
- Repair and paint fascia and trim in the area around the front cross and repaint the large cross
- · Repair (and where necessary replace) fascia, trim, and siding on building exterior
- Make necessary roofing repairs
- Replacing the bell tower with a new functional bell tower design

The Trustees request Thrivent members to apply for Action Team grants to complete the following projects during the 2016 calendar year:

- Painting the building exterior as a community event
- Painting and replacing carpeting in the Gathering Room
- · Construction of improved storage in the basement and painting the church office
- · Making updates to the lighting and appearance of the loft area in the sanctuary

The Trustees recommend having detailed plans drawn up during the 2016 calendar year for the following projects to be completed during the 2017 calendar year:

- A comprehensive kitchen upgrade (A special funding campaign would be required)
- Upgrading the men's toilet (Approved by previous action but not undertaken)
- Repair or replacement of the concrete and stone retaining wall and railing

The Trustees are reviewing the following projects for consideration in 2017 or 2018:

- New wooden signs (We will continue to experiment with banners until then)
- New paint and carpeting in the basement
- Replacement of basement windows

Parsonage:

The Trustees have approved replacing the double glazed picture window in the parsonage "TV" room as the seal has broken. The Trustees will also be working with Pastor Daren to identify other needs in the parsonage and will be drawing up plans for the exterior of the parsonage for consideration in 2018.

Constitution Committee: Updates are still being done and the committee will let us know when it is ready for the congregation's review.

Bell Tower / Electronics: - thinking of moving the bell tower to the back of the church so we can ring the bell before each service. Eric Iverson has been looking into this issue.

Church Directory: - we will look at doing something in the Spring once all our snow birds are back. But it was suggested that we look into another vendor then the one we used last time.

Pastor Daren's Report

These last 7 months have been months of great transition for the Blanck family. We've moved from a big town in a little country to a little town in a big country. Everyone speaks English and there are lots of friendly faces here, but in some ways its been just as challenging as any foreign country - with different schools, different positions, different friends, and different ways things are done. The congregation of Zoar Church has welcomed us with open arms and we are grateful to be here!

Sometimes a new pair of eyes (or in my case one "new" eye) sees things from a fresh perspective, so before I loose that perspective, in my report this year I'd like to identify those things I see as strengths of Zoar and those challenges I see going forward before I report on what your pastor has been up to since August 1!

I believe this congregation has some great strengths moving forward:

- 1) Zoar is committed to the truth of the Gospel. We live in an age that has been described many as "post-Christian." The institution of the church is less central in our society and the voice of the Biblical witness is often not heard in our public discourse. This means it is more difficult for churches to maintain vitality and visibility in the public square. Many churches have abandoned the gospel in an attempt to stay "relevant" only to find that they are as marginal as ever. However, the message of the gospel never changes! With the Apostle Paul "we preach Christ crucified!" (1 Corinthians 1:23) Modern mankind is as affected by sin and a fallen world as much as the first century Corinthians, and Jesus says, "My grace is all you need." (2 Corinthians 12:9)
- 2) Zoar supports a wide range of missions and ministries locally and internationally. We are called by Christ into service to our communities and our world. From CHUM to the Seed Company, from the Cook County Food Shelf to Evergreen Mission Congregation in Saipan, the ministries that Zoar supports reflect a sense of North Shore community mindedness along with a wide vision for what it means to be a part of the global Body of Christ. Thank you deacons!
- 3) Zoar recognizes both the rich history of the Lutheran liturgical tradition and the freedom of contemporary worship. The historic liturgy reminds us of the "great cloud of witnesses" who have gone before us in faith. Contemporary worship in many ways is a return to the simple worship style of the first century and upbeat praise music and a warm, informal atmosphere resonates with a younger generation.

Many congregations are in the midst of fighting "worship wars" while Zoar has simply found a comfortable place alternating between these worship styles. Thank you Generations and Lavona!

- 4) Zoar has a great facility in a great location. Our history and presence in the community make possible opportunities to witness to our neighbors in Word and deed. Unlike many LCMC congregations, Zoar isn't looking for or renting space, paying off a mortgage, or facing major repairs. Thank you trustees!
- 5) Zoar's leadership is strong and cohesive and as a member of the LCMC we are a part of a growing association rather than a declining denomination. Some congregations are facing inner turmoil, conflicts between congregational leaders or difficulties with called pastors. Many congregations are dealing with denominational structures that require ever growing contributions as membership declines. I have enjoyed seeing Zoar's leaders work

Again the Bloodmobile was at Zoar in March, July and November. The Blood Center was enthusiastic about the turn-out and collection.

Zoar and

Lutsen Churches rang bells for the Salvation Red Kettle Drive at Tofte General Store on 4 Saturdays in November and December. \$672 were collected.

Many hats, scarves, and mittens were given to the Mitten Tree at Christmas for donation to missions in Duluth and Grand Marais. In addition, 4 hats were knitted for the neonatal unit at St Mary's Hospital in Duluth.

A Missions Committee was formed in March. Marsha Hansen, Linda Lamb, Judy Gregg, and Polly Erickson attended the 2 planning sessions in March and November. In March it was decided that the monthly mission donations for 2015 would be as follows: March - Cook County Foodshelf, April - Starfish Fund (establishment), May - Yust (Selkees), June - Starfish Fund (Angela Cook), July - Teen Challenge, August - Cook County Foodshelf, September - Military Bible Sticks, October - Refugees in Macedonia, November - CHUM Shelter, December - The Seed Company (Galen Johnson). A very generous total of monies given was \$2,540. Also, quarterly Zoar donates \$200 to LCMC to support missions.

At the November Missions Committee Meeting it was decided upon the following monthly mission schedule for 2016: January - East European Network - Vision Petrozavodsk, February - Evergreen Mission Church on Saipan, March - Cook County Foodshelf, April - The Seed Company, May - Teen Challenge, June - Starfish Fund (Angela Cook), July - (probably new Lutheran teen home in Duluth), August -- Cook County Foodshelf, September - Military Bible Sticks, October - Samaritan's Purse and churches in Macedonia, November - CHUM Shelter, December - LAMP (Native Americans).

Deacons' Report

The Deacons are responsible, under the leadership of the Pastor, for the spiritual life, education, and mission of the congregation.

Communion is served twice per month on the first and fourth Sundays of the month. In 2015 an average of 35 people received communion each time. Priscilla Revier scheduled and oversaw the communion services. This way we have communion at a Worship and Praise Service, and a Traditional Service.

During the summer from July through August a second service was held outdoors at Father Baraga's Cross on the rocks at the mouth of the Cross River in Schroeder. An average of 18 worshipers attended each Sunday.

Usually on the second and fourth Sundays of the month, music was provided by the worship band, Generations for Christ. On most other Sundays Judy Gregg played, although, towards the end of the year, Lavona Czaplicki became the pianist.

Most Wednesdays during the school year Birch Grove Bible Club (later changed to Good News Club) met in the Birch Grove Library at 3:15. 11 students from preschool ages through 5th grade attended the lessons taught by Pastor Carlson in the spring and Pastor Blanck in the fall. They were aided by volunteers from the congregation who also served a snack to the children.

5 times a year the pastor and volunteers are responsible for services at the Care Center in Grand Marais. They provide not only the service, but also music and refreshments for the residents.

Each Thursday morning a group of adults gather for a Bible Study of the previous Sunday's text led by the pastor from 10:00 to 11:

A collection of used pill bottles was begun to be given to Pastor Carlson for sending to the Malawi Project. The people there use the bottles to carry home their medications from clinics and hospitals.

Deacon Carol Markwell headed up the Blessed to be a Blessing stewardship program this fall which obtains Estimates of Giving and Serving of the members for the coming year.

For I am not ashamed of the gospel of Christ, for it is the power of God to salvation for everyone who believes ... (Romans 1:6)

I also believe that we have some challenges ahead:

- 1) Zoar must become locally missional to its core in order to remain a vital and important part of the Tofte-Schroeder North Shore Community. Like the over all demographics of the North Shore, our congregation is aging. Zoar church needs to find ways to welcome back nominal or former members, better share the Gospel message with the community, and invite the next generation into the fellowship of grace if it is to survive. Zoar is the only church on Highway 61 between Palisades Head and Lutsen. That means that we have a mission field of over 500!

 2) Zoar must find new ways to serve the social, economic, and spiritual needs of the Tofte-Schroeder North Shore Community. With taconite and power company lay-offs, a still slow tourism economy, and the lingering effects of past forest fires and foreign competition affecting the logging industry, the North Shore is in an economic pinch. Should we be offering a weekly community meal even beyond the lenten season? What should our ministry to international workers look like? Are we doing everything we can to serve the marginalized in our community? How are we as a congregation going to truly be the beacon of Hope on the North Shore?
- 3) Zoar must become agile in welcoming young people when they enter our building and continue to adapt to trends in contemporary worship. Young people are the key to our growth in the future. How will we welcome them when they come to worship with us? Research suggests we've got one opportunity to impress our ministry and mission on them once they walk through our doors. Generations continues to provide inspirational praise music twice each month, but finding and practicing new music is a challenge for any praise band. More musicians and especially more "generations" would help.
- 4) Zoar must deal with several building maintenance issues. The treasurer's report deals with several of these issues. While none of them are crippling, it will take funding creativity, a sustained effort, and a growing budget to maintain this beautiful building.

... You shall be witnesses to Me in Jerusalem, and in all Judea and Samaria, and to the end of the earth. (Acts 1:8)

I have been excited to be a part of a few accomplishments - some for me and some for Zoar:

- 1) Preaching a combination of exegetical and topical sermons and reintroducing sung liturgy from the ReClaim hymnal during Sunday morning worship. I'd like to keep this mix going in the future.
- 2) Writing several newspaper articles and articles for four Zoar newsletters. These and weekly worship service preparation have been the biggest time commitments for me here at Zoar.
- 3) Leading a packed Christmas Eve worship service and officiating for the funeral of a well known and respected local resident and member of Zoar. Both were firsts for me!
- 4) Posting sermons and newsletters on zoarchurch.org. With the assistance of Tina and Elijah, I believe Zoar has a great web presence that our "snow-bird" members have already

commented on as a good way to keep up with our ministry here while they are gone. Our goal is to use Zoar's website as an outreach tool as well.

- 5) Teaching Zoar's Bible Club at Birch Grove Community Center in cooperation with Child Evangelism Fellowship as a Good News Club. Michelle, Judy, and other volunteers have been invaluable in making this program a fun, effective way to share the gospel with community kids.
- 6) Beginning regular Youth and Family Night Activities. These have been moderately successful but I've learned some great lessons and hope to be able to grow these outreach and fellowship programs into the future.
- 7) Studying God's Word everyday but especially during Thursday Bible Study with a core group of Zoar and community members. We have lots of fun and some very lively discussion. These folks have truly become my fellow travelers and prayer warriors.
- 8) Designing and helping to mount new banner-signs proclaiming who we are and what's going on at Zoar. Elijah, Sophia, and I also did a little painting and repair to the sign closest to the road.
- 9) Reconfiguring the upstairs office for use as a gathering room for education, fellowship, leadership meetings, and community events. In addition this space can be more easily used during worship times as a "crying room" and as a congregational library.
- 10) Moving the Pastor's Study downstairs and organizing storage space behind the elevator. With minimal expense I have a great study and work space nearer to the office and out of the way. Thanks Skip, Spencer, and Bill for your help!
- 11) Purchasing 200 Outreach New Testaments and beginning the process of delivering them door to door. Along with a new tri-fold brochure explaining who we, these New Testaments are a part of our outreach and evangelism for Zoar Church and the Kingdom of God. Sharing a New Testament is a great way to say "Hi, I'm the new pastor, I'd like to invite you (or invite you back) to Zoar Church, and we'd like to give you this free gift." Each New Testament has a "Plan of Salvation" guide and is one of the newer translations in modern English.
- 12) Completing the Beyond the River Academy New Testament: Johannine Literature course in August of 2015 and completing the Beyond the River Academy Early Church History course in February 2016. My paper entitled The Cross and the Crescent: The Rise of Islam, Its Connection to Ancient Heresy, and Our Response was shared with a group of 20 LCMC pastors for review with a positive recommendation.

Audit Committee Report

January 18, 2016

This year the Audit Committee examined the 2015 financial records and inquired as to the accounting procedures of Zoar Church with church treasurer Tina McKeever. There have been no changes in bookkeeping procedures or book keeping policy during 2015.

The examination included the following:

- We inquired as to the monthly bookkeeping and reconciliation procedures performed during the year. These are the same as in previous years using Quick Books software.
- The church has 4 bank accounts. There are 3 accounts at the Grand Marais State Bank (Saving, CD#2, and Checking). There is one savings account at North Shore Federal Credit Union. We reviewed the accounts as of December 31, 2015 and found them to agree with the yearend balance sheet.
- We reviewed the insurance premium notices and determined that insurance for church building and contents, liability and workers compensation were current and adequate at this time
- We reviewed Profit and Loss, Balance Sheet and Income Statement as of December 31, 2015. We found no discrepancies between reports and actual conditions.
- We inquired as to accounting procedures and controls for cash. In general, the church receives very little cash in the collection plate on Sunday. If cash is greater than \$20.00 on the offering plate, two people verify the amount. When more cash is received i.e. as with a fundraiser, or a large service such as Christmas Eve, or Easter services, two people count the cash receipts.

Currently Zoar has 3 employees; Pastor, Secretary and Bookkeeper/Custodian, which is one employee.

The church has one credit card issued by the Grand Marais Bank. It has a \$2000.00 limit. Currently the card is used for inter-net purchases of supplies and other items needing advance payment.

As documented August 10, 2008 at the semi annual congregational meeting, unless previously budgeted, purchases over \$1000.00 require a congregational vote.

Two signatures are required on each check written.

Our insurance provider is Brotherhood Mutual. We have a 2-year contract and payments are made quarterly and subject to audit adjustments. This policy also provides liability insurance for the pastor. Our workmen's compensation policy, also held by Brotherhood Mutual, is paid quarterly.

The accounts of Zoar Church are well organized and in good order. It is easy to access account information.

On behalf of Zoar Lutheran Church, we would like to thank our Bookkeeper Elizabeth Peterson and Treasurer Tina McKeever for their conscientious work in keeping the financial records of the Church.
